In the event that one focus group participant requests that their session not be recorded, the researchers will honor the request. All information that is obtained during this session will be kept confidential and stored in a secure locked cabinet and on a password protected computer. No identifying information will be contained in any reporting of the results and there will be no way to link any statements you may make back to you. Though there may be little direct benefit to the participant, the benefits of this study for society are significant as it will help us understand how the Alliance program impacts students' success in the mathematical sciences.
